

2415.04 TITLE I - PARENTAL INVOLVEMENT (M)

M GENERAL EXPECTATIONS

The school district will put into operation programs, activities, and procedures for the involvement of parents in all of its schools with Title I, Part A programs, consistent with Section 1118 of the Elementary and Secondary Education Act (ESEA). Those programs, activities, and procedures will be planned and operated with meaningful consultation with parents of participating children.

Consistent with Section 1118, the school district will work with its schools to ensure that the required school-level parental involvement policies meet the requirements of Section 1118(b) of the ESEA, and each include, as a component, a school-parent compact consistent with Section 1118(d) of the ESEA.

TITLE I - PARENTAL INVOLVEMENT (M)

2. The school district will, with the assistance of its schools, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:
- a. Conducting the Annual Title I / Basic Skills Parent Workshop which focuses on Parent Involvement in the content areas of Language Arts Literacy, Mathematics and the incorporation of technology in the teaching /learning process;
 - b. Resource materials are also provided through the district's website "Parent Library" available in both English and Spanish.
3. The school district will, with the assistance of its schools and parents, educate its teachers, pupil services personnel and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
- a. In-service workshops both in and out of district;
 - b. Conferencing and obtaining input with parents of children who have a variety of educational needs.



4. The school district will take the following actions to ensure that information related to the school and parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:
 - a. All important informational fliers and notifications are sent home in both English and Spanish;
 - b. The use of a telephone communication service in both English and Spanish;
 - c. Notifications posted on the district's website.

ADOPTION

This District-Wide Parental Involvement Policy has been developed jointly, and agreed on with parents of children participating in Title I, Part A programs. This Policy will be distributed to all parents of participating Title I, Part A children in an understandable and uniform format and, to the extent practicable, in a language the parents understand, at the beginning of each school year or when the child is determined eligible and begins participating in Title I, Part A programs.
