## NO NEW STUDENT OR TRANSFER STUDENT WILL BE PERMITTED TO ENTER SCHOOL WITHOUT A PHYSICAL EXAMINATION FROM A PHYSICIAN OR WITHOUT FULFILLMENT OF ALL IMMUNIZATION REQUIREMENTS

- ★ **<u>BEFORE</u>** entering <u>PRESCHOOL</u> your child will need the following immunizations:
  - 4 doses of DTaP (Diphtheria, Tetanus and Pertussis)
  - 3 doses of IPV (Polio)
  - 3 doses of Hepatitis B vaccination
  - 1 dose of MMR (Measles, Mumps, and Rubella) -after 1st birthday
  - 1 dose HIB (Haemophilus Influenzae type B) -<u>after</u> 1<sup>st</sup> birthday
  - 1 dose Varicella (Chickenpox Vaccine) -after 1st birthday
  - 1 dose PCV (Pneumonia Vaccine) –**after** 1<sup>st</sup> birthday
  - Annual influenza vaccine (Flu Vaccine) is recommended for all ages, however, it is **MANDATORY FOR ALL PRESCHOOL STUDENTS**

★ **<u>BEFORE</u>** entering <u>KINDERGARTEN</u> your child will need the following immunizations:

- 5 doses of DTap (Diphtheria, Tetanus and Pertussis) -1 dose <u>after</u> 4<sup>th</sup> Birthday
- 4 doses of IPV (Polio) -1 dose <u>after</u> 4<sup>th</sup> birthday
- 3 doses of Hepatitis B Vaccine
- 2 doses of MMR (Measles, Mumps, and Rubella)
- 1 dose Varicella (Chickenpox Vaccine) –<u>after</u> 1<sup>st</sup> birthday

 $\star$  **<u>BEFORE</u>** entering <u>6th Grade</u> your child will need the following immunizations:

- Tdap Booster given to each student no earlier than their 10<sup>th</sup> birthday
- Meningococcal Vaccine given to each student no earlier than their 11<sup>th</sup> birthday

**OFFICIAL IMMUNIZATION RECORD Required as Proof of Immunization Completion.** 

- > All STUDENTS are recommended to have a yearly physical by a physician.
- > All Student-Athletes are MANDATED to have a yearly physical by a physician or they will not be allowed to play.
