Report of the Superintendent:

Mr. Chirichella opened his discussion by providing the board with the current enrollment which is at 241 students. He shared some good news with the board which included Mrs. Moreno's 8th grade class as the Bulldogs of the Month for the best attendance for the month of April. Mr. Chirichella recognized the work of the The Green Thumb/Science Club. He thanked Mrs. Thom and the middle school students for all their hard work and a profitable business selling vegetables and plants and raising funds for student activities.
