Regular Meeting Minutes Monday, January 8, 2024

A regular meeting of the Board of Education was held on Monday, January 8, 2024, in the Gymnasium of Memorial School, 1 Dyer Avenue, South Hackensack, New Jersey.

The meeting was called to order at 7:01 p.m. by the President, Ms. Paladino

Ms. Paladino read the following statement:

Report of the Superintendent:

Mr. Chirichella opened his discussion by giving the board the current enrollment which is at 240 students. He shared some good news with the board which included Ms. Carbah's 4th grade homeroom as the Bulldogs of the Month for the best attendance for the month of December. Other matters discussed included the district hosting the South Hackensack Invitational Basketball Tournament which will run from Wednesday through Friday. Mr. Chirichella thanked the coaching staff for all their hard work in setting up the tournament and the 8th grade parents for volunteering their time to assist with the operations. A Pep Rally is scheduled for Wednesday to kick things off. The MP2 is coming to a close at the end of this month and the Honor Roll Assembly is scheduled for February 2nd, at 2:30 p.m. He informed the board that the Negotiations Committee is currently working on the teachers contract negotiations and that the 2024-2025 budget preparations are currently being worked together with him and the business office. A draft will be presented to the Policy and Finance Committee soon. He informed the board that the February 12, 2024 meeting has to be changed either the location or date due to the BYBL Tournament that is going to be held at Memorial School during February. The board agreed to move the date to February 5, 2024.

OPEN PUBLIC HEARING: Mr. Padalino discussed the heating system in the district. Mr. Aguilar informed the board that he had met with Automatic Logic in regards to some of the issues within the district regarding the regulation of the heating system. They are currently working on resolving this matter. Adjustments were made so that the controls are operating correctly and during the hours that the district is in session. This adjustment to the controls should impact a decrease in the energy consumption. Mr. Paladino also asked Mr. Aguilar to look into Solar panels for the district. Mr. Paladino wanted to have the district bring back more cultural arts, field trips and activities including the Science Fair. Since the district is currently working on the budget this would be a great time to discuss and have some of these in place for the 2024-2025 school year. Mr. Chirichella stated that the board just approved 2 staff members to work on a cultural arts performance for this spring. In regards to field trips, the district does support the trips, but the cost of the transportation continues to be externally high. Due to the high costs of buses the burden to offset the cost of the trip would fall on the students and the parents. Students are currently working on projects and going to have a market fair sometime in the spring to show the products they are making and selling them as part of financial literacy. The students are also involved with the Solar Car racing that Mrs. Thom has been involved with the students for a couple of years now.
