Regular Meeting Minutes Monday, February 5, 2024

A regular meeting of the Board of Education was held on Monday, February 5, 2024, in the Gymnasium of Memorial School, 1 Dyer Avenue, South Hackensack, New Jersey.

Report of the Superintendent:

Mr. Chirichella opened his discussion by recognizing our School Safety Officer, Ms. Laura Schreck for her amazing and quick efforts in a health and safety situation last week. Ms. Schreck administered the Heimlich maneuver to a third grade student. A classmate of the choking student alerted Ms. Schreck who happened to be in the vicinity during the lunch period. The classmate was recognized and a Super Bulldog certificate was presented to him, Mr. Chirichella thanked Ms. Schreck on his behalf and on behalf of the board for her services to the district. Ms. Schreck was not able to attend tonight's meeting but was invited to attend the next board meeting in March. Mr. Chirichella then continued his report by giving the board the current enrollment which is at 241 students. He shared some good news with the board which included 6 students of the Month of January for the Positive Characteristics Theme, Mrs. Boland's 3rd grade homeroom as the Bulldogs of the Month for the best attendance for the month of January. Other matters discussed included the Honor Roll Assembly for Marking period 2 for grades 4 -8. He congratulated all the students who received Honor Roll Recognition and High Academic Honor Roll. He updated the board in regards to the Negotiations with the Teachers Association EASH. The contract negotiations committee has begun their meetings and proposals have been exchanged.
