# Regular Meeting Minutes Monday, March 12, 2018

#### Report of the Superintendent:

Mr. Maceri opened his report by informing the board that the State figures for the 2018-2019 budget were not available until later in the week. Due to the delay from the State, the district would schedule a Special Board meeting to approve the preliminary budget. He suggested maybe around March 26, 2018 so as to give the board more time to look over the numbers. The board felt that they would be fine with an earlier date of March 19, 2018. Since the majority of the board was in agreement with the date, Ms. Schaefer stated that she would advertise. He then continued with his report by giving the board the current enrollment which stands at 295. He provided the board with dates for the Science Fair and the L.E.A.D.S. graduation. Mr. Maceri stated the Mr. Perdomo had reached out to him regarding two matters: one was the donation of bleachers to the district and the other was to ask if the board would consider allowing the residents to use the playground and soccer field, as Veterans Park was being redone. The board did not see a problem with either matter. Ms. Davis just wanted to make sure it did would not interfere with the soccer program in the summer or any other school functions. Regarding the donation of the bleachers, Ms. Schaefer wanted to make sure that the bleachers had railings for insurance purposes.
