SOUTH HACKENSACK BOARD OF EDUCATION Regular Meeting Minutes Monday, May 13, 2019

A regular meeting of the Board of Education was held on Monday, May 13, 2019, in the Media Center of Memorial School, 1 Dyer Avenue, South Hackensack, New Jersey. The meeting was called to order at 7:30 p.m. by the Vice President, Mr. Donatello
