# Regular Meeting Minutes Monday, March 8, 2021

A regular meeting of the Board of Education was held on Monday, March 8, 2021. Meeting was held remotely through the use of electronic equipment.

The meeting was called to order at 7:00 p.m. by the President, Mr. Donatello

#### Report of the Interim Superintendent:

Dr. Hayes opened his discussion by giving the board the current enrollment for the district which is currently at 260. He stated that 172 students are in person and that 88 students are still full remote. Dr. Hayes informed the board that on February 24, 2021 a restart committee meeting was held to discuss Phase 3 of the reopening of school. He informed the board of the decision that the administration and the restart committee discussed on the elimination of the blue and gold cohort and aimed for a March 22, 2021 reopening date to 5 days a week of in person instruction. He further stated that letters were sent out to the community regarding these changes. Only parents that wanted to make a change were asked to respond to the survey that was sent out. The district will continue to be vigilant with mask wearing, desk shields, temperature screenings and no class to class movement except for physical education and pull outs. He further stated that the district is excited to offer this 5 day in person instruction and thanked the restart committee, the board of education, the parents, and the teaching staff for all their support during this time. Dr. Hayes asked if the board had any questions on his report. No questions were voiced. Mr. Donatello thanked Dr. Hayes for all his hard work to get the district reopened. Mr. Donatello then asked if there were any questions or comments on the consent agenda. No questions or comments were voiced on any of the resolutions.
