# SOUTH HACKENSACK BOARD OF EDUCATION Regular Meeting Minutes Monday, December 14, 2020

A regular meeting of the Board of Education was held on Monday, December 14, 2020. Meeting was held remotely through the use of electronic equipment.

The meeting was called to order at 7:01 p.m. by the President, Ms. Paladino

#### Report of the Acting Superintendent:

Mr. Chirichella opened his discussion by sharing some good news with the board and citizens. Last month, Mrs. Criscione, with the help of Mrs. Watts, Miss Carroll and Mrs Castillo completed a committee food bank project. A total of \$142.00 was raised and donated to the New Jersey Community Food Bank of NJ. Each dollar served 3 Thanksgiving Day meals to families in need. Ms. Gould completed a holiday lesson with the lower grades on gingerbread. Students had fun making gingerbread cookies after the lesson. Mrs. D'Elia's 5th grade class made signs and special notes to inspire each other and their teacher. Mr. Chirichella provided the current enrollment which stands at 273. He discussed the district goals update which included the implantation of the new math series for grades Pre-K to 8, the implementation of the new Pearson Elevate Science and the implementation of the SeeSaw program in the lower grades. He informed the board that the district administered the Strong Start Assessment which was put out by the Department of Education for grades 4 to 8. Testing was done within 2 days for these grades. He continued his report by giving the number of attendees for conference week which was done via zoom. He discussed the holiday festivities for the district, the board reorganization meeting date and the request from the Township Committee to use the school's gym to hold their board meeting on January 7, 2021. Ms. Davis asked Mr. Chirichella to share the results of the Strong Start Assessment with the board once it becomes available. Mr. Donatello thanked Ms. Duva and Mrs D'Amico for the phenomenal work that they both have done and continue to do with the Pre-K students and the virtual learning. He further stated that their hard work will not go unnoticed. He thanked Mr. Chirichella for his leadership in the school.
