Regular Meeting Minutes Monday, September 18, 2017

A regular meeting of the Board of Education was held on Monday, September 18, 2017, in the Media Center of Memorial School, 1 Dyer Avenue, South Hackensack, New Jersey. The meeting was called to order at 7:30 p.m. by President, Ms. Davis

OPEN PUBLIC HEARING: Mr. Falato addressed the board regarding issues that his daughter is having with certain students in her class. He stated that this has been an ongoing matter since last school year and it continues. He feels his daughter has been harassed and bullied and he wanted to bring this matter before the board. His daughter had issues over the summer where there was damage done to his and her property. The police were involved in this matter. Mr. Falato stated that some of the bullying and harassment is done on social media. Mr. Maceri stated that he understands that Mr. Falato is frustrated as a parent, like any other parent would be, but the school did take the appropriate measures when the incidents happen in the 2016-2017 school year. Mr. Maceri stated that the incident over the summer was a police matter and was being taken care through the police department. Students involved in the incidents at school were disciplined based on the code of conduct. Mr. Maceri stated that he could not go into full discussion in public regarding this matter, but students involved were suspended. Mr. Maceri stated that an investigation is always done once matters are brought to his attention. Mr. Falato stated that the district did follow procedures but he felt that not enough was done to make his daughter feel comfortable coming to school. Mr. Maceri stated if there is a case of cyber bullying where evidence is brought to the school by either the parent or the student and that evidence shows that it was happening outside of the school and is affecting what is happening inside the school he stated yes then it absolutely becomes a school matter and it will be addressed with all parties involved and the right discipline will be put in place. Mr. Maceri stated he was not aware of any incident in the current school year until today, when Mr. Falato showed up at the board meeting to address it. Mr. Maceri stated that if this matter was brought to him right when it happened he would have done an immediate investigation. Mr. Maceri stated that he cannot discipline on a matter that the police are involved in. He was made aware of the situation but the matter was being handled by the police. Also one of the individuals involved over the summer incident was not a South Hackensack resident. Mr. Maceri reinforced the importance of screenshots of any posted information either via text, snapchat, Facebook on any other social media website/apps be saved. This gives the district evidence of the incidents which then can be addressed with the appropriate staff and the board attorney if necessary. The board attorney will get involved and give the district the appropriate

protocol. Ms. Davis thanked Mr. Falato for attending the board meeting and voicing his concerns. She stated that the district will continue to protect all students and make them feel comfortable and safe coming to school. Mr. Maceri stated that the law regarding the definition of bullying does not do justice for people who are targeted. The law did not go far enough to protect and he does not agree with the definition of the law. He stated that this frustrates parents and educators but the procedures need to be followed by the law.
