

**SOUTH HACKENSACK BOARD OF EDUCATION**  
**Public Hearing Meeting Minutes**  
**Thursday, April 27, 2017**

A Public hearing meeting of the Board of Education was held on Thursday April 27, 2017, in the Media Center of Memorial School, 1 Dyer Avenue, South Hackensack, New Jersey. The meeting was called to order at 7:00 p.m. by President, Ms. Davis
