

SOUTH HACKENSACK BOARD OF EDUCATION
Work Session Meeting Minutes
Monday, May 1, 2017

A work session meeting of the Board of Education was held on Monday, May 1, 2017 in the Media Center of Memorial School, 1 Dyer Avenue, South Hackensack, New Jersey. This meeting was called to order at 7:30 p.m. by the President, Ms. Davis.

Ms. Davis read the following statement:

The New Jersey Open Public Meetings Law was enacted to insure the right of the public to have advance notice of and to attend the meetings of the public bodies at which any business affecting their interests is discussed or acted upon. In accordance with the provisions of the Act, the South Hackensack Board of Education has caused notice of meetings published in The Record by having the date, time and place thereof posted. Notice was also placed on the Bulletin Board in the Municipal Building and in the Lobby of Memorial School.

Roll call was taken by Elizabete Schaefer, Board Secretary, and the following members responded to their names:

Discussion Items:

Mr. Maceri opened his discussion by reviewing the resolutions with the board. Resolution #5 regarding the donation of tables from the Township Committee and Senior Citizens Club Mr. Maceri stated that he appreciated the donation as the district would definitely have use for them. Mr. Maceri asked the board when they would like to schedule the year end meeting. Since the full board was not present, this date and time would be discussed at the Regular board meeting of May 8, 2017. Ms. Anzevino inquired about Resolution #13 regarding the hiring of non-tenured teachers. Mr. Maceri stated that the list provided did not include 3 of the most recent hired teachers.
