SOUTH HACKENSACK BOARD OF EDUCATION

Regular Meeting Minutes Monday, May 8, 2017

A regular meeting of the Board of Education was held on Monday, May 8, 2017, in the Lunch Room of Memorial School, 1 Dyer Avenue, South Hackensack, New Jersey. The meeting was called to order at 7:30 p.m. by President, Ms. Davis

Ms. Davis read the following statement:

The New Jersey Open Public Meetings Law was enacted to insure the right of the public to have advance notice of and to attend the meetings of the public bodies at which any business affecting their interests is discussed or acted upon. In accordance with the provisions of the Act, the South Hackensack Board of Education has caused notice of meetings published in The Record by having the date, time and place thereof posted. Notice was also placed on the Bulletin Board in the Municipal Building and in the Lobby of Memorial School.

Ms. Davis read the following statement:

Residents are requested to state their names, addresses and subject matter. Issues raised by members of the public may or may not be responded to by the Board. All comments will be considered and a response will be forthcoming if and when appropriate. The Board asks that members of the public be courteous and mindful of the rights of other individuals when speaking. Specifically, comments regarding students and employees of the District are discouraged and will not be responded to by the Board. Students and employees have specific legal rights afforded by the laws of New Jersey. The Board bears no responsibility nor will it be liable for any comments made by members of the public. Members of the public should consider their comments in light

of the legal rights of those affected or identified in their comments and be aware that they are legally responsible and liable for their comments.

Open Public Hearing: Meeting was opened to citizens @7:33 p.m.

Several Parents addressed the board regarding the incident that occurred at the district back in October 19, 2016 when Mr. Masullo disconnected the loud speaker in his computer Lab which resulted in the students that where in his computer class to miss a bomb threat and therefore did not evacuated the building. The parents were upset that this incident was not addressed with them when the incident occurred and once it was published and posted on social media that is when they found out about Mr. Masullo and what had happened and that he would be returning to his position as a teacher at Memorial School in September 2017. The parents felt that due to him being tenured he is protected and felt that was more important than the safety of the students. Parents were upset that no criminal charges were filed against him and are angry that an arbitrator would allow him to come back. Parents felt that Mr. Masullo could no longer be trusted as he refused to take responsibility for his actions and covered up the incident. Parents did not feel safe having their children in his class when he returns and asked the school how they are going to move forward after this incident so that it does not ever happen again. Mr. LaPira the school board attorney stated that he feels the frustration of the parents as so does the board but due to confidentiality on this matter, information could not be provided more than what was available from the State of New Jersey Department of Education that came out regarding the tenure charges. Mr. Masullo was suspended without pay until September 2017, when he will be reinstated as a teacher. He will not be entitled to a pay raise or compensated for lost wages. Mr. LaPira explained the legal procedure of this matter and informed the public that the board was clearly disappointed on the arbitrator's decision. Mr. Maceri stated that he did hear what everyone had to say on this matter and their concerns. The district will do a process of checking the speaker systems and that they are working properly and have not been tampered with. He assured the parents that he would be speaking to the staff about the consequences when the safety drills are not followed. Mr. Maceri informed that the parents that the safety and security of the students is his number one priority. He informed the parents that the district does 2 safety drills a month, a fire drill and a safety drill that needs to be followed by all staff members. Regarding the question on what training the district will provide to staff, Mr. Maceri stated that he would sit down with this employee and go over the expectations of the district and to make sure that the safety and security of the students and staff is not to be jeopardized. He further stated that the district took the appropriated action regarding this matter unfortunately the penalty was not the penalty the board felt was appropriate. Mr. Maceri stated that he wants the parents to know that the district shares their frustration and that the board is passionate about the decisions they made pursing this matter, even though the outcome was not in their favor. He further stated that it is now our duty as a district to sit and figure out what is appropriate to make sure the community feels safe and that the community has trust in us as a board, him as the Principal and Superintendent and our teaching staff. Mr. Maceri stated that he believes when parents state "that we have to work as a community" sometimes it is very frustrating in a very personal level when we are not able to discuss certain matters with the community. Mr. Maceri stated that he appreciates everybody coming out and what everybody had to say. He stated that he had empathy with the parent's anger and in time what he asks is that the parents and community trust that we will come together as a board to be able to make the decisions we need to make which is that everybody in the district is safe and doing the right thing for this district. Mr. LaPira stated that Mr. Masullo's and the board's position are all explained in the arbitrator's decision. Mr.

Maceri stated that the things that the citizens are bringing up regarding accountability is to please first understand that the arbitrator's decision is very recent and its a decision that the board and him will be sitting and discussing on what we think the best avenue is going to be to help everybody feel that their children will be safe. He further stated that any other options that the board can take regarding this matter will be addressed with the board attorney. Right now the district has to abide by the arbitrator's decision, even though this was not what the district wanted as the outcome. Ms. Davis together with the board thanked the citizens for coming out to the meeting and appreciates their presence and that the board understands their frustration and their concerns. She further stated that the children's safety is the district's number one priority and the district will continue to make sure that all safety procedures are followed.
