NOW, THEREFORE, BE IT RESOLVED that the Board has determined that *Laura Schreck* shall be authorized to carry firearms on school property, effective November 15th, 2022 provided that *Laura Schreck* shall carry on her person a copy of the applicable permit(s) to carry firearms all times when on school grounds.

BE IT FURTHER RESOLVED that the Board President shall provide *Laura Schreck* with written notice of such authorization, along with a copy of this resolution, before she is permitted to carry a firearm on school grounds.
