Regular Meeting Minutes Monday, February 11, 2019

A regular meeting of the Board of Education was held on Monday, February 11, 2019, in the Media Center of Memorial School, 1 Dyer Avenue, South Hackensack, New Jersey. The meeting was called to order at 7:30 p.m. by the President, Mr. Aquilina
