# SOUTH HACKENSACK BOARD OF EDUCATION Regular Meeting Minutes Monday, April 11, 2022

A regular meeting of the Board of Education was held on Monday, April 11, 2022, in the Gymnasium of Memorial School, 1 Dyer Avenue, South Hackensack, New Jersey.

## Report of the Superintendent:

Mr. Chirichella opened his discussion by giving the board the current enrollment for the district which is at 266 students. He discussed the virtual Honor assembly for the third marking period that was held today and was happy to report that there were a total of 55 students that received honors and 21 students with high honors.
