# SOUTH HACKENSACK BOARD OF EDUCATION

# Regular Meeting Minutes Monday, December 9, 2019

A regular meeting of the Board of Education was held on Monday, December 9, 2019, in the Media Center of Memorial School, 1 Dyer Avenue, South Hackensack, New Jersey. The meeting was called to order at 7:30 p.m. by the President, Mr. Aquilina

Mr. Aquilinai read the following statement:

The New Jersey Open Public Meetings Law was enacted to insure the right of the public to have advance notice of and to attend the meetings of the public bodies at which any business affecting their interests is discussed or acted upon. In accordance with the provisions of the Act, the South Hackensack Board of Education has caused notice of meetings published in The Record by having the date, time and place thereof posted. Notice was also placed on the Bulletin Board in the Municipal Building and in the Lobby of Memorial School.

Presentations: Ms. Higgins and the student council attended the board meeting to discuss the food drive that was held at Memorial School. This year the school collected over 2200 food items to be delivered to the Meadowlands Family Success Center for their Fall food drive. The board thanked the student council, the students of Memorial School and the teachers for a job well done. Mr. Maceri thanked Ms. Higgins and Mrs. Moreno for their hard work in putting this food drive and all the students for the great community service. Mr. Maceri also informed the board that Mrs. Criscione has been involved in a community service project with students from 2nd to 8th grade. "The Quiltmaker's Gift" through the generosity of the students was able to donate 554 meals to the less fortunate. Ms. Davis thanked and congratulated the Student Council on a job well done by all.

Mr. Chirichella then made his presentation to the board on the attendance initiative. Mr. Chirichella provided slides to explain this initiative and why it works. The district has seen great progress and there has been an improvement on absenteeism and tardiness. He explained

the tardy policy that the district has in place and the discipline issued for tardiness. Mr. Chirichella explained the incentive program for grades Pre-K to 1, grades 2 to 4 and 5 - 8. The board had an opportunity to ask questions and get more information on this initiative. Mr. Maceri and the board thanked Mr. Chirichella for his presentation.

#### Report of the Superintendent:

Mr. Maceri opened his discussion by providing the board with the current enrollment which is at 285 students. Other matters discussed included the Tree Lighting with Ms. Taveras and the Little Ferry Basketball Tournament. The Block Grant for the school field was discussed. Mr. Maceri met with the township to further investigate this project. He continued his report by discussing

the Holiday fund, conference week attendance report, Honor Roll for the 1st marking period, winter registration for Pre-Kindergarten and Kindergarten which is scheduled for December 16 and December 17, 2020. The township was notified of this registration and it would post on Town sign on Phillips Avenue. The school wide celebration was scheduled for December 20, 2019 at 11:45 a.m. Mr. Maceri informed the board that the Parisi family had Jimmy Parisi's ashes put in a keepsake urn and one was given to the district. He suggested that the district do something special with it and asked the board to come up with some suggestions of where and how this should be displayed within the district. Mr. Donatello made a suggestion that maybe we can also do something with the field honoring Mr. Parisi. Mr. Maceri then continued his report by asking the board if there were any questions or comments on any of the resolutions on the consent agenda.
