### **LEA Response Table**

1) Universal and correct wearing of masks

([count] of 1000 maximum characters used)

Face coverings are currently optional in the school buildings, grounds and activities. Students and staff may choose to wear face coverings at their discretion. Parents and staff may make face masking decisions based on their specific situation, for example, if a student or staff member or their family members are immunocompromised or at higher risk of severe illness from COVID-19. The district supports mask use by students and staff who choose to mask at any time.

2) Physical distancing (e.g., including use of cohorts/podding)

According to the CDC website, it is recommended to use precautions to prevent spread, including staying home and away from others (including people you live with who are not sick) if you have respiratory symptoms. Staying home when sick can lower the risk of spreading infectious diseases to other people.

People who are at risk for getting very sick with COVID-19 who test positive should consult with a healthcare provider right away for possible treatment, even if their symptoms are mild. The district is aware of considerations for high-risk activities during high COVID-19 hospital admission levels. Within and outside of classrooms, schools maintain physical distancing to the greatest extent practicable in any situation.

### 3) Handwashing and respiratory etiquette

The district promotes behaviors that mitigate the spread of COVID-19 such as encouraging staff and students to stay home when appropriate and encouraging the practice of hand hygiene and respiratory etiquette. Hand washing and hand sanitizing are permitted and encouraged throughout the school day. Our school maintains hand sanitizing stations with alcohol-based hand sanitizer. Such stations are located in each classroom; at entrances and exits of buildings; near lunchrooms and toilets; children five and younger are supervised when using hand sanitizer. School staff have developed a school-wide plan where students are required to wash hands at least 20 seconds at regular intervals during the school day and always before eating, after using the bathroom, and after blowing their nose, coughing and/or sneezing.

### 4) Cleaning and maintaining healthy facilities, including improving ventilation

The district adheres to the South Hackensack custodial cleaning procedures. In addition, the department follows the cleaning schedule developed by the district's custodial staff. The district maintains an adequate supply of cleaning supplies, including hand sanitizer, gloves, and face coverings to allow for a two-month supply. The staff disinfects during the school day for touchpoints, including but not limited to, phones, door handles, light switches, handrails, etc.

### 5) Contact tracing in combination with isolation and quarantine, in collaboration with the State, local, territorial, or Tribal health departments

Schools have transformed from a case-investigation model to a routine disease control model. This model focuses more on responding to clusters of cases, outbreaks, and evidence of ongoing transmission in schools and less on individual case investigation and contact tracing. The district still files a weekly CDTSS

from, as required for the New Jersey Communicable Disease Reporting and Surveillance System. Procedures for symptomatic staff and students include student and staff with symptoms are safely and respectfully isolated from others. Students remain in isolation with continued supervision and care until picked up by an authorized adult. The district follows current Communicable Disease Service Guidelines for illness reporting. An adequate amount of PPE is available, accessible and provided for use.

6) Diagnostic and screening testing

The New Jersey Department of Health recommends that schools work with their Local Health Department to identify rapid viral testing options in their community where they can refer ill or exposed students and staff. The CDC no longer recommends routine screening testing in schools. According to the CDC website regarding testing and what you need to know from May 2, 2024, it states that COVID-19 testing can help you know if you have COVID-19 so you can decide what to do next, like getting treatment to reduce your risk of severe illness and taking steps to lower your chances of spreading the virus to others." Repeated testing may be necessary.

7) Efforts to provide vaccinations to educators, other staff, and students, if eligible

For COVID-19, staying up to date with COVID-19 vaccinations is the leading public health strategy to prevent severe disease. It provides individual-level protection and high vaccination coverage which reduces the burden of COVID-19 on people, schools, healthcare systems, and communities. The district distributes all health notices, including notices of locations offering vaccines or boosters. Most pharmacies now offer the vaccines.

8) Appropriate accommodations for children with disabilities with respect to health and safety policies

Reasonable accommodations were provided for individuals that the CDC identified as having a higher risk for severe illness from COVID-19 such as medically fragile students with Individualized Education Programs (IEPs), students with complex disabilities with IEPs, or students who require accommodations under a plan in accordance with Section 504 of the Rehabilitation Act of 1973 (504 Plan). Accommodations were also made for those younger students or individuals with disabilities in accordance with all applicable

laws and regulations.

The district has identified certain needs that were funded by the CRRSA-ESSER II grant and continue to be funded under the ARP-ESSER III grant to provide a continuation of services for students and staff impacted by the COVID-19 pandemic. The district has increased its use of interactive technology, particularly for students with disabilities in our primary grades (PreK-1). Therapeutic care was provided for identified students who have experienced isolation, trauma, depression and anxiety. The therapeutic care included individual and family counseling to support students' academic success and mental health needs. Summer programs in English language arts and math occurred during summer 2023 and will again occur during the summer of 2024.

The Safe Return to In-Person Instruction and Continuity of Services was initially approved by the South Hackensack Board of Education on June 28, 2021; updates were approved on February 7, 2022, June 22, 2022, December 27, 2022, and June 14, 2023, and December 11, 2023. The current update was approved as an amendment on June 24, 2024. These approvals occurred at public meetings of this governing body. There were opportunities for public discussion at these meetings and at subsequent Board of Education meetings. The reopening committee will continue to review this template and the ARP Mandatory Subgrant Award for revisions as required. Public comment will be solicited as required by the subgrant award. Updated plans are posted on the district website.
